Tax-Exempt Income Earned by State, Commonwealth or Territory of the United States (as a percentage)

Some states allow the mutual fund shareholder to reduce the amount of tax-exempt income they include on their state income tax return by the proportionate amount of tax-exempt income that they receive from their mutual fund that is derived from tax-exempt obligations issued within their State or by a Commonwealth or Territory of the United States. The following schedule indicates the percentage of tax-exempt income that is earned by the **Aspiriant Risk-Managed Municipal Bond Fund** from State, Commonwealth, or Territory of the United States obligations. A portion of the federally tax-exempt income dividends paid during the calendar year represents income from private activity bonds issued after August 7, 1986 except for those issued in 2009 or 2010. This income represents a tax-preference item for alternative minimum tax (AMT) purposes and should be included in your AMT computation, if you are required to perform an AMT computation.
